Sarah Capes is a third-year PhD candidate undertaking interdisciplinary research at the University of London's School of Advanced Study, supervised from within the Centre for Latin American and Caribbean Studies at the Institute for Languages, Cultures and Societies and the Institute of Commonwealth Studies. She holds a bachelor's degree in Spanish and Latin American Studies, a master's in philosophy, and a PGCE in Modern Foreign Languages. As both teacher and student, she focuses on real-world issues of social and global injustice. Her current research examines the conceptualisation of Indigenous peoples' perspectives in international environmental politics.

Jérémie Gilbert

Jérémie Gilbert is Professor of Social and Ecological Justice at the University of Southampton (UK). His main area of research is on international human rights law, and he has extensively published on the rights of Indigenous peoples, looking in particular at their right to land and natural resources. As a legal advocate, he has worked with several Indigenous communities to support their fight to ensure the respect of the fundamental rights to land and territories. He has recently led the establishment of the Interdisciplinary Network on the Rights of Nature, he is a board member of the Peoples Planet Project an organisation assisting indigenous communities in their battle against deforestation through documentaries and participatory films; as well as a proactive member of Clean Trade an organisation advocating against corrupted exploitation of natural resources, and a member of the Global Alliance on the Rights of Nature academic Hub, as well as strategic legal advisor for Lawyers for Nature.

Dr Adriana Giunta

Dr Adriana Giunta is a Visiting Research Fellow at the British Institute of International and Comparative Law working on a funding proposal on Defining Environmental Rights under International law, and towards the publication of her monograph on Indigenous Peoples' Environmental Rights under International Law. Her research on environmental rights - Giunta A., 'Looking Back to Move Forward: The Status of Environmental Rights under the UN Declaration on the Rights of Indigenous Peoples' [2019] IJHR Vol. 23 (1-2), https://doi.org/10.1080/13642987.2019.1572874 - was cited among other scholars by the UN Environment Programme's second report on Environmental Rule of Law: Tracking Progress and Charting Future Direction in 2023.

In June 2019, Adriana was invited to Geneva by the former UN Special Rapporteur Boyd and the UNEP together with another 29 experts at a closed-door invitation-only meeting of experts to discuss the potential development of a new environmental right, which was adopted in Resolution 48/13 in October 2021, by the UN Human Rights Council. Previously, she was invited to contribute with new knowledge in the field, and the UNEP's work and book, with the chapter - 'Can an Ecocentric Approach Open New Frontiers for a Legally Binding International Environmental Right? A Study of Norway's Environmental Constitutional Right', published in New Frontiers in Global Environmental Constitutionalism, 2017.

She is an academic, activist and advocate. She has taught and researched human rights, indigenous peoples, climate change, the environment and international law, as a Lecturer at the University of London and Brunel University London, and as a Visiting Fellow and Research Fellow at the NIEM/Arctic Centre at the University of Lapland in Finland. She has worked for NGOs, including Amnesty International and the Equal Rights Trust. She holds a PhD in Indigenous Peoples' Environmental Rights under International Law, an LL.M in International Human Rights Law and a B.A. in Law and Human Rights.

Dr Kanika Godara

Dr Kanika Godara is an Assistant Professor at the School of Liberal Education at Galgotias University. She pursued her honours in English at Miranda House, University of Delhi, a Master's in English from Panjab University, and completed her doctoral degree at The Central University of Haryana. Daniel Kobei

Daniel Kobei is an esteemed Founder and Executive Director of the Ogiek Peoples Development Program (OPDP), where he has dedicated the past 20 years to empowering Indigenous communities. His extensive experience includes networking with Indigenous organizations globally, facilitating collaboration and advocacy on critical issues. As a representative of Indigenous peoples (IP) at the Convention on Biological Diversity (CBD), Daniel underscores the vital integration of traditional knowledge in biodiversity conservation efforts. An expert in land policies affecting marginalized societies, he has played a crucial role in advancing the Ogiek community's land rights. His leadership was instrumental in achieving the landmark ruling by the African Court on Human and Peoples' Rights on May 26, 2017, which affirmed the Ogiek's ancestral land rights in the Mau Forest. The subsequent reparation judgement on June 23, 2022, further solidified this victory. He has advocated for the rights of Ogiek and other IPs in Permanent Forum on Indigenous Issues (PFII) in New York and on Expert Mechanism on right of IPs (EMRIP) in Geneva.

Kalyani Madavi

Kalyani Madavi is an independent researcher and a first-generation law student at National Law University, Mumbai. She belongs to the Gond Adivasi community. In a professional capacity, she mentors students from historically marginalized communities and has led over 20 online career guidance sessions for Adivasi youth with the Gondola community group. She also spearheads the Adivasi Women's Health Support Nationwide initiative, conducting over 10 sessions on women's health in collaboration with the Gondola community (central India) and Dhumkudiya Muddha, Ranchi. An Intellectual Property Rights enthusiast, she is passionate about safeguarding Indigenous knowledge and cultural expression. Her research interests include Adivasi rights, law, and environmental justice

Ojot Miru Ojulu

Ojot Miru Ojulu is a PhD holder in Peace Studies with a research focus on Minorities and Indigenous Peoples Rights from the University of Bradford in the UK. Deborah Delgado Pugley

Deborah Delgado Pugley is the 2024-2025 Cogut Visiting Professor at Brown University and Associate Professor of Sociology at the Pontificia Universidad Católica del Perú. She is also a Visiting Scholar at KU Leuven and a research associate for the Andes Amazon Program at the Field Museum in Chicago. Her research, grounded in fieldwork in Peru, Bolivia, and Brazil, explores environmental and climate policies, Indigenous movements, human rights, and gender. She teaches courses on social theory, politics in Panamazonia, and environmental policies in Latin America. Delgado Pugley co-authored En un ambiente tóxico.
